LAST DAY TO CANCEL STALL(S) IS MARCH 1, 2024. **QUALIFYING WAIVED FOR STAKE/CHAMPIONSHIP CLASSES IF ENTRY FEES PAID FOR QUALIFYING CLASS.** ABSOLUTELY NO HORSES WILL BE ALLOWED BEFORE 8:00AM TUESDAY MORNING. Under South Carolina law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in an equine. Neither ASAC nor the owner of the Grounds will be responsible for accidents or loss that may occur to person, animals, or property. Negative Coggins, taken within 12 months of show is required and be submitted with entries or shown before numbers are released. Show enforces Safe Sport suspended/banned list and follow all applicable ASHA and/or USEF Rules.

ENTRIES CLOSE MARCH 1, 2024. Entries made after this date will be charged a \$10 post entry per horse. Fees must be paid before back numbers are issued. ASHBA HORSE NUMBER MUST BE INCLUDED!

ALL ACCOUNTS MUST BE SETTLED BY 6:00 PM ON MARCH 9th

The facility has 440 permanent stalls. Please make stall reservations early to ensure availability. **Stalls will be \$120 each and No stall will be reserved unless payment in full accompanies request.** No horses will be allowed before 8:00am on Tuesday, March 5th. Shavings must be ordered on entry form. Shavings/bedding may not be brought in from outside Garrison Arena. A grounds fee of \$30 per horse charged for non-stalled horses. One night academy stalls for \$60 each.

SHOW MANAGEMENT RESERVES THE RIGHT TO REFUSE ANY AND ALL ENTRIES OR TO RETURN ANY MONEY PAID FOR ENTRY FEES. Any returned check will be assessed a returned check fee if presented to a bank and is un-collectable. Full camper hookups available at \$40 per night. Reserve on entry form or call Dan Shirley at 864-630-1669. Any exhibitor, trainer or barn who has outstanding fees, including but not limited to non-sufficient checks, stop payment checks, disputed credit card charges, etc. will not be permitted to show and/or exhibit until fees have fully been satisfied. Campers, please check in a horse show office. If you are arriving after office hours electrical boxes will not be open! Please make prior arrangements with Dan Shirley. A limited number of reserved tables including snacks with 6 seats for \$250 are available on a first come, first serve basis, and may be ordered on the entry blank.
